## TERMS & CONDITIONS

- I. Payment:** Full payment is required no later than **1<sup>st</sup> July 2024**.
- II. Allocation of sites:** The organisers reserve the right to re-allocate space in the interest of a better showing of exhibits. Any specific requests need to be placed on the Application Form for consideration. *All sites will be allocated by the stall coordinator.*
- III. Stall holders:**
  - Are responsible for stall/display which must always be supervised;
  - If using a canopy/gazebo it must always be secured or weighted down;
  - Must leave the site area clean and tidy from rubbish, etc at the end of the event;
  - Must have prior approval for camping on the grounds.

**IV. Vehicles:** ALL vehicles **must** carry a Site-Holders parking permit, available from the Site Coordinator.

Vehicles conveying supplies and/or vehicles owned or used by Site-holders are not permitted to remain for more than 30 minutes in the designated site area.

**ALL** Vehicles **must** be removed and parked in designated Site-holders parking area by 4pm Friday & 8.30am Saturday. Vehicles found outside the designated area or those failing to display the parking permit, may be towed at the owners expense. For access outside of these hours, please consult the Stall Coordinator.

**V. Electricity connections:** All electrical leads and equipment must be tested & tagged safe, **BEFORE THE FESTIVAL** as per Workplace Health and Safety governance requirements. These items must meet minimum weatherproof standards, be located and secured away from public traffic areas.

**VI. Set Up:** The Moura Recreational Grounds will be accessible from **Thursday 15th August. NO earlier.**

**VII. Free standing displays:** All displays must be secured to avoid fall injuries.

**VIII. Gambling:** Disposal of any articles by lot or chance, and/or the sale of Art Union and or raffle tickets is strictly prohibited.

**IX. Offensive material/hawking:** The Stall Coordinator has the power to enter the site at any time and remove any article, sign, picture or printed matter which in his/her opinion may cause offence to the public. The Site Exhibitor must confine their business to the purpose described within the application. **Selling/hawking, or distribution of printed matter is not permitted outside of the site area.**

**X. Banned items:** Site-holders **Please Note:** page 4 delineates the list of Banned Items please familiarise yourself with this and do not bring these items to the Festival.

**XI. Cancellation:** Cancellation must be applied for in **writing** to the Site Coordinator **minimum fourteen days** prior to the commencement of the festival. Failure to do so will result in a forfeiture of deposit. A site area or part thereof may not be sublet or transferred to another entity or person.

- XII. Permission:** I give permission for Moura Coal and Country Festival to take and use photos of me, for the purpose of publicity, social media promotion, illustrations, advertising and/or website content associated with the Festival.
- XIII. Liability Insurance:** The Moura Coal and Country Festival shall not be responsible for any damages claimed by any person/s, who maybe injured whilst in the allocated site and the Site-holder agrees to indemnify the Moura Coal and Country Festival in the event of any claim made directly against the Site-holder or against the Moura Coal and Country Festival pertaining to the site.
- XIV. Sale of specific items:** The Moura Coal & country festival reserves the right to prohibit the sale of specific items. I.e. we try to encourage our local community groups to participate in the festival. Accordingly if a local group is selling a specific item, the committee may request the applicant to refrain from selling that item. I.e. Hot chips or donuts. If you do not agree to accept this direction from the stall holder coordinator, please do not proceed with your application.

*In consideration of the acceptance of me as a Stall Holder at the Moura Coal and Country Festival, I agree to indemnify the organisers and each of them in the following manner:-*

- a. That I acknowledge I have read, understood, and agree to be bound by the Terms and Conditions.*
- b. That I accept the venue as it stands with all or any defects hidden or exposed;*
