TERMS & CONDITIONS

- I. **Payment:** Full payment is required no later than 1st July 2025.
- II. Allocation of sites: The organisers reserve the right to re-allocate space in the interest of a better showing of exhibits. Any specific requests need to be placed on the Application Form for consideration. All sites will be allocated by the stall coordinator.

III. **Stall holders:**

- Are responsible for stall/display which must always be supervised;
- If using a canopy/gazebo it must always be secured or weighted down;
- Must leave the site area clean and tidy from rubbish, etc at the end of the event;
- Must have prior approval for camping on the grounds.



IV. Vehicles conveying supplies and/or vehicles owned or used by Site-holders are not permitted to remain for more than 30 minutes in the designated site area.

ALL Vehicles **must** seize movement by 4pm Friday & 8.30am Saturday. For access outside of these hours, please consult the Stall Coordinator.

V. Electricity connections: All electrical leads and equipment must be tested & tagged safe, *BEFORE THE FESTIVAL* as per Workplace Health and Safety governance requirements. These items must meet minimum weatherproof standards, be located and secured away from public traffic areas.

VI. Set Up: The Moura Recreational Grounds will be accessible from Thursday 14th August. NO earlier.

- VII. Free standing displays: All displays must be secured to avoid fall injuries.
- **VIII. Gambling:** Disposal of any articles by lot or chance, and/or the sale of Art Union and or raffle tickets is strictly prohibited.
 - IX. Offensive material/hawking: The Stall Coordinator has the power to enter the site at any time and remove any article, sign, picture or printed matter which in his/her opinion may cause offence to the public. The Site Exhibitor must confine their business to the purpose described within the application. Selling/hawking, or distribution of printed matter is not permitted outside of the site area.
 - **X. Banned items:** Site-holders **Please Note:** page 5 delineates the list of Banned Items please familiarise yourself with this and do not bring these items to the Festival.
 - XI. **Cancellation:** Cancellation of a site must be made in writing on or before July 1st 2025. Α refund will be processed minus the deposit. Please email: mouracoalcountryfestival@gmail.com The Festival is not obliged to make any refunds for any cancellation received after July 1st. However, payments may be refunded upon written evidence of illness, accident etc. If a refund is offered the deposit will be forfeited. A site area or part thereof may not be sublet or transferred to another entity or person.
- **XII. Permission:** I give permission for Moura Coal and Country Festival to take and use photos of me, for the purpose of publicity, social media promotion, illustrations, advertising and/or website content associated with the Festival.



- XIII. Liability Insurance: The Moura Coal and Country Festival shall not be responsible for any damages claimed by any person/s, who maybe injured whilst in the allocated site and the Site-holder agrees to indemnify the Moura Coal and Country Festival in the event of any claim made directly against the Site-holder or against the Moura Coal and Country Festival pertaining to the site.
- XIV. Sale of specific items: The Moura Coal &country festival reserves the right to prohibit the sale of specific items. I.e. we try to encourage our local community groups to participate in the festival. Accordingly if a local group is selling a specific item, the committee may request the applicant to refrain from selling that item. Ie. Hot chips or donuts. If you do not agree to accept this direction from the stall holder coordinator, please do not proceed with your application.

In consideration of the acceptance of me as a Stall Holder at the Moura Coal and Country Festival, I agree to indemnify the organisers and each of them in the following manner:-

- a. That I acknowledge I have read, understood, and agree to be bound by the Terms and Conditions.
- b. That I accept the venue as it stands with all or any defects hidden or exposed;
- c. That I indemnify and hold harmless the volunteers, organisers, their respective servants, agents or officials, against any actions or claims which may be made by me or on my behalf, or by other parties for or in respect of or arising out of my death or any injury or loss or damage caused to me or my property whether caused by negligence, breach of contract or in any other manner whatsoever.
